1. It is mandatory for the candidate, proposer, seconder to be a member of Solapur Janata Sahakari Bank Limited, Gaganbharari Shivasmarak Sankul, Goldfinch Peth, Solapur And his name must be included in the final voter list.
2. It is mandatory for the candidate or his nominee, to file a Nomination form in the prescribed format 'Form II' For Board of Directors and 'Form V' for Office Bearer, to the Returning Officer OR ARO within the prescribed time limit.
3. The eligibility of the candidate to contest elections as a Board of Director and Office Bearer as per Sec 29, 43 and 44 of the Multi state Cooperative Societies Act and also as per Rules 19J, 19K and 19L of MSCS Rules.
4. As per the bye-laws of Solapur Janata Sahakari Bank Limited, a candidate should be eligible to contest elections as a Board of Director and Office Bearer.
5. Candidates Contesting from the Scheduled Castes and Scheduled Tribes constituency are required to attach the certified copy of **caste Certificate** issued by the competent authority of their caste alongwith their nomination paper.
6. A candidate or his nominee or representative (authorized in writing by the candidate) may give written notice of **withdrawal of his/her candidature** to the Returning Officer or Assistant Returning Officer within the prescribed time.
7. It will be necessary for all the Contesting Candidates to submit the details of their election expenses as the provisions of MSCS Rules 19(U), (V), (W), (X) and to adhere to the code of conduct.
